Turkey's competition bar remains small compared to other jurisdictions, but is experiencing steady growth.

The firm also advised JPMorgan Chase, Citibank and Sumitomo Mitsui during an investigation by Turkey's Competition Authority evaluating whether 12 financial institutions violated Turkish law through the exchange of information regarding loan conditions and other competitively sensitive information. The enforcer fined a few of the banks but did not impose any administrative fines on the three companies represented by ELIG.
